#### Information for doctor:

· Most important symptoms and effects, both acute and delayed:

Prolonged inhalation of excessive levels of a trade secret component of this proprietary formula may cause a benign pneumoconiotic condition, not normally associated with a decrement in lung function. In cases of longterm exposure to extremely high levels of dust, progressive fibrosis may occur with lung function impairment.

A trade secret component of this proprietary formula can cause silicosis, a fibrosis (scarring) of the lungs. Silicosis may be progressive; it may lead to disability and death; inhaled from occupational sources is classified as carcinogenic to humans. Some studies show in workers exposed to respirable hazards associated with this component excess numbers of cases of scleroderma, connective tissue disorders, lupus, rheumatoid arthritis, chronic kidney diseases and end-stage kidney disease, chronic bronchitis and emphysema.

· Indication of any immediate medical attention and special treatment needed:

Observation only is required for adult ingestion of a few grams of GB. For ingestion of larger amounts, maintain adequate kidney function and force fluids. Gastric lavage is recommended for symptomatic patients only. Hemodialysis should be reserved for massive acute ingestion or patients with renal failure. Boron analysis of urine or blood are only useful for documenting exposure and should not be used to evaluate severity of poisoning to guide treatment.
